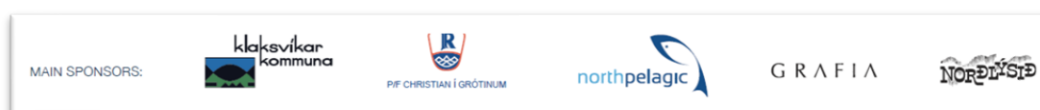

Due to the Corona/Covid-19 outbreak, the organizers for Atlantic Fair 2021 have decided to change the deadlines for the participations as follows:

- Deadline for cancel your participation will be postponed to 18. March 2021, at no cost.
- Participation fee will not be invoiced before 1st. April 2021.
- No later than March 18, it will be finally decided whether the fair can be held or not, and in case of cancellation, no charge will be made.

CONDITION

1. The registration is binding, and the exhibitor is liable for the total amount of the registration and stand booking fee.
2. **Cancellation of participation:** If an exhibitor wishes to cancel the registration, the cancellation fee of the total contract amount is as follows:

before 1 st October 2020:	0% cancellation fee	Before 1 st January 2021:	25% cancellation fee.
before 1 st February 2021:	50% cancellation fee	After 1 st March 2021:	100% cancellation fee.
3. **Terms of payment:** Registration fee and stand rental will be invoiced on 4th January 2021. Companies, which register after 4th January 2021, will be invoiced straight away. Payments fall due 14 days after the invoice date. 0.5% interest per month will be added to overdue invoices. Companies, which do not pay before 1st March, can expect to lose their allocated space.
4. **STAND WITH WALLS** is constructed with standard white walls (sides and back wall), stand number and company name. A **CORNER/END STAND** will have one/two open sides, otherwise as above. **SPACE ONLY** will be built entirely by the exhibitor himself. The exhibitor will have to present a sketch in advance for approval and within 1st of May 2021. If standard stand walls are not to be used, this must be notified to the organizer. If a **TWO FLOOR** stand is to be constructed, or with walls higher than 2.5 meters it must be approved by the organizers. Talk with the organizers about special conditions such as these. **OUTDOOR AREA** will be delivered as an open space.
5. The Organizer has the unreserved right to refuse to accept bookings, to refuse objects for exhibition and to adjust and possibly reduce the area applied for. Furthermore, the Organizer has the final decision with regard to the allocation of space.
6. Posters, etc. may not be put in the exhibition area without written permission from the Organizer. Product samples and advertising material may be handed out from the stand only. Sound that is disturbing to other exhibitors are not allowed.
7. Floor Loading/Maximum weight in the exhibition halls is 400 kg. pr. square meter.
8. The exhibitor is responsible for all hired equipment including compensation for any damage done to the buildings, furnishings, installations and persons.
9. The Organizer will have security guards on at the exhibition day, but is not responsible for the exhibited commodities, equipment and property of any third person. The exhibitor must himself meet all necessary insurance costs.
10. If, by order from the authorities, or due to force majeure the exhibition must be cancelled, the Organizer is not responsible for the extra costs, obligations or loss incurred by the exhibitor.
11. If the fair is cancelled, the stand and registration fees will be refunded. Other costs that exhibitors have incurred will not be refunded. The organisers reserve the right to relocate or change the dates for the fair, this will not give the exhibitors the right to claim a refund.
12. The exhibitor must himself take care of all transport, assembling, dismantling, packing and driving away of his equipment and decoration materials. All goods intended for the exhibitor must be well marked with his name at the number of the stand.
13. The Organizer is responsible for the cleaning of the indoor and outdoor isles for the public, as well as the daily cleaning of the stands.
14. When the exhibition has been dismantled, the stand is to be left free of decorations, foundations, etc. If this is neglected, the Organizer reserves the right to have the necessary cleaning done at the expense of the exhibitor.
15. Registrations are committed to follow the above regulations, regardless of any reservations made of any kind.
16. All exhibitors are responsible for obeying the Faroese laws and are responsible for obtaining the necessary permits in connection with the fair from the relevant authorities.
