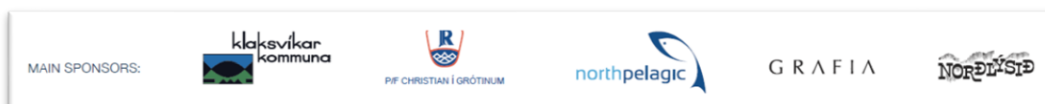

TERMS AND CONDITIONS

1
The registration is binding, and the exhibitor is liable for the total amount of the registration and stand booking fee.

2
Cancellation of participation: If an exhibitor wishes to cancel the registration, the cancellation fee of the total contract amount is as follows:

before 1st September 2027:	0% cancellation fee
before 1st January 2028:	25% cancellation fee
before 1st March 2028:	50% cancellation fee
after 1st March 2028:	100% cancellation fee

3
Terms of payment: The registration fee and stand rental will be invoiced in January 2028. Companies which register after 1st January 2028 will be invoiced immediately. Payment is due 7 days after the invoice date. Interest of 0.5% per month will be added to overdue invoices. Failure to comply with the payment terms may result in the stand being allocated to another exhibitor.

STAND WITH WALLS is constructed with standard white walls (side and back walls), stand number and company name.
CORNER/END STAND will have one/two open sides; otherwise as above.
SPACE ONLY will be built entirely by the exhibitor. The exhibitor must submit a sketch for approval in advance and no later than 1st April 2028. If standard stand walls are not to be used, this must be notified to the Organizer.
TWO-FLOOR STANDS or stands with walls higher than 2.5 meters must be approved by the Organizer. Please contact the Organizer regarding such special conditions.
OUTDOOR AREA will be delivered as an open space.

The Organizer reserves the right to refuse bookings, reject exhibition objects, and adjust or reduce the allocated area. The Organizer has the final decision regarding space allocation.

6
Posters, etc. may not be displayed in the exhibition area without written permission from the Organizer. Product samples and advertising material may only be distributed from the stand. Sound that disturbs other exhibitors is not allowed.

7
The maximum floor load in the exhibition halls is 400 kg per square meter.

8
The exhibitor is responsible for all hired equipment, including compensation for any damage to buildings, furnishings, installations, or persons.

9
The Organizer will provide security during the exhibition, but is not responsible for exhibited goods, equipment, or property belonging to third parties. The exhibitor must arrange all necessary insurance.

10
If the exhibition is cancelled by order of the authorities or due to force majeure, the Organizer is not responsible for any additional costs, obligations, or losses incurred by the exhibitor.

11
If the fair is cancelled, stand and registration fees will be refunded. Other costs incurred by exhibitors will not be refunded. The Organizer reserves the right to relocate or change the dates of the fair; this does not entitle exhibitors to a refund.

12
The exhibitor is responsible for transport, assembly, dismantling, packing, and removal of equipment and decoration materials. All goods must be clearly marked with the exhibitor's name and stand number.

13
The Organizer is responsible for indoor cleaning. All stands will be vacuum-cleaned and garbage removed every night.

14
All exhibitors must comply with Faroese law and are responsible for obtaining the necessary permits from relevant authorities.
